Purpose of processing of personal data	Providing services on demand. Customer identification for repeated contact.
Legal basis for the processing of personal data	Legal requirement resulting from Act 89/2012 Coll. Law Civil Code Part Four - Relative property rights based on the voluntary provision of personal data in demand for creation of the offer.
Recipients of personal data	Employees of Mr. Sajid Mujkić, or third party contractor who will supply the service.
Intention to transfer personal data to a third country or international organization	The Personal Data Manager does not intend to transfer personal data to a third country or international organization without the prior written consent of the data subject.
Time of storing personal data	Personal data are maintained until the consent to their processing is not revoked or the legal obligations resulting from their processing have expired.

Right of objection against personal data processing	This right can be claimed by a request sent electronically to the e-mail address transport@melektaxi.eu or personally at the branch of the processor.
Right to transfer personal data	This right can be claimed by a request sent electronically to the e-mail address transport@melektaxi.eu or personally at the branch of the processor.

Right to withdraw consent to the processing of personal data	Each subject have right to withdraw consent to the processing of personal data. Right to file a complaint with the Supervisory Authority	The data subject has the right to file a complaint with the Office for Personal Data Protection .

In the event of failure to provide the relevant data, it is not possible for the data subject to make an offer for our services.
Automated decision making and profiling of personal data	There is no automated individual decision making or profiling of personal data.
